**EUROPEAN COMMUNITIES (AUTHORIZATION, PLACING ON THE
MARKET, USE AND CONTROL OF PLANT PROTECTION
PRODUCTS) (AMENDMENT) REGULATIONS 2010**

I, BRENDAN SMITH, Minister for Agriculture, Fisheries and Food, in exercise of the powers conferred on me by section 3 of the European Communities Act 1972 (No. 27 of 1972), for the purpose of giving effect to Commission Directive 2009/115/EC of 31 August 2009¹, Commission Directive 2009/146/EC of 26 November 2009², Commission Directive 2009/152/EC of 30 November 2009³, Commission Directive 2009/153/EC of 30 November 2009⁴, Commission Directive 2009/155/EC of 30 November 2009⁵, Commission Directive 2009/70/EC of 25 June 2009⁶, Commission Directive 2009/77/EC of 1 July 2009⁷, Council Directive 2009/82/EC of 13 July 2009⁸, Commission Directive 2009/116/EC of 25 June 2009⁹, Council Directive 2009/117/EC of 25 June 2009¹⁰ and Commission Directive 2009/154/EC of 30 November 2009¹¹, hereby make the following Regulations:

1. (1) These Regulations may be cited as the European Communities (Authorization, Placing on the Market, Use and Control of Plant Protection Products) (Amendment) Regulations 2010.

(2) The reference to Commission Directive 2009/154/EC of 30 November 2009 shall not enter into force until 1 April 2010.

2. The European Communities (Authorization, Placing on the Market, Use and Control of Plant Protection Products) Regulations 2003 (S.I. No. 83 of 2003) are amended, in Regulation 2(1), by substituting for the definition of “Directive of 1991” (inserted by the European Communities (Authorization, Placing on the Market, Use and Control of Plant Protection Products) (Amendment) (No. 3) Regulations 2009 (S.I. No. 222 of 2009)) the following—

EXPLANATORY NOTE

(This note is not part of the Instrument and does not purport to be a legal interpretation)

These Regulations transpose the amendments to Annex I of Council Directive 91/414/EEC with regard to the purity level required of the active substance metazachlor and as regards the common name and the purity of the active substance hydrolysed proteins.

These Regulations also transpose the amendments to Annex I of Council Directive 91/414/EEC with regard to the expiry date for inclusion in Annex I of the active substance carbendazim and by including the following active substances into that Annex:

Difenacoum, didecyldimethylammonium choloride, sulphur, chlorsulfuron, cyromazine, dimethachlor, etofenprox, lufenuron, penconazole, tri-allate, triflusulfuron, tetaconazole, methomyl, paraffin oils CAS No. 64742-46-7, CAS No. 72623-86-0, CAS No. 97862-82-3 and paraffin oil CAS No. 8042-47-5, aluminium phosphide, calcium phosphide, magnesium phosphide, cymoxanil, dodemorph, 2,5-dichlorobenzoic acid methylester, metamitron, sulcotrione, tebuconazole, triadimenol and cyflufenamid.

These substances are pesticides.
