PESTICIDES CONTROL ACT (CAP. 430)

Plant Protection Products (Amendment) Regulations, 2011

IN exercise of the powers conferred by articles 4 and 5 of the Pesticides Control Act, the Minister for Resources and Rural Affairs, in consultation with the Prime Minister and with the Minister for Health, the Elderly and Community Care, has made the following regulations:-

1. (1) The title of these regulations is the Plant Protection Title and scope. Products (Amendment) Regulations, 2011 and they shall be read and construed as one with Plant Protection Products Regulations, 2009, hereinafter referred to as "the principal regulations".

- The scope of these regulations is to transpose Commission Directive 2010/70/EU and Commission Directive 2010/77/EU in so far as they amend Schedule I to the principal regulations.
- Schedule I to the principal regulations shall be amended as follows: -
