Report Highlights:

China recently announced that 124 additional products used for human food, animal feed additives, and certain industrial uses will be subject to import and export inspection by inspection and quarantine agencies at entry-exit ports starting May 15, 2007.

Executive Summary

On May 11, 2007, the State General Administration for Quality Supervision, Inspection and Quarantine (AQSIQ) published on its web site a joint announcement with other government agencies stating that the inspection and quarantine authorities (CIQ's) at ports will begin mandatory inspection of an additional 124 import or export products used for human food, animal feed additives and their raw materials as of May 15, 2007. This announcement broadens CIQ and Customs authority over products that previously required no export or import documentation other than standard Customs documents.

The purpose of the new requirement is to tighten government surveillance on import and export of food in the wake of exports of mislabeled products from China. The impact on trade is expected to be small. However, it will add another layer of export or import documentation for exporters and importers of these products.

At this time, AQSIQ has not clarified exactly what measures are included in this mandatory "inspection." In other contexts, completion of a *Customs Clearance Form on Entry/Exit of Goods* can include document checks, checking documents versus the physical product, and various degrees of physical inspection of goods. In addition to the CIQ inspection, Customs will also be instructed to only process these goods when they are accompanied by proof of CIQ's inspection.

Announcement on Implementing Entry-Exit Inspection and Quarantine on Products Used for Human Food, Animal Feed Additives and Raw Materials

No.70 (2007) April 30, 2007

In order to strengthen the surveillance of import and export inspection and quarantine on products used for human food, animal feed additives and raw material, pursuant to pertinent provisions of the Law of the People's Republic of China on Import and Export Commodity Inspection, it is hereby decided to list 124 products used for human food, animal feed additives and raw materials into the Catalogue of Entry-Exit Commodities Subject to Inspection and Quarantine by Entry-Exit Inspection and Quarantine Authorities, for the purpose of the surveillance by entry-exit inspection and quarantine authorities.

Enterprises must report to entry-exit inspection and quarantine authorities at import and export ports when importing or exporting products listed herewith:

- 1. The entry-exit inspection and quarantine authorities shall inspect the reported products used for human food, animal feed additives and raw materials and customs shall clear the products based on the *Customs Clearance Form on Entry/Exit of Goods* issued by entry-exit inspection and quarantine authorities.
- 2. For products used only for industrial purposes instead of for human food, animal feed additives and raw materials, enterprises must submit a trade contract and a certificate indicating such products are not used for human food, animal feed additives and raw materials. The entry-exit inspection and quarantine authorities shall verify these documents and issue a *Customs Clearance Form on Entry/Exit of Goods* without inspection. The customs shall clear the products based on the *Clearance Form on Entry/Exit of Goods* issued by the entry-exit inspection and quarantine authorities.

This Announcement shall come into force as of May 15, 2007.
