**OCCUPATIONAL HEALTH AND SAFETY AUTHORITY ACT  
(CAP. 424)**

**Protection of Workers from the Risks related to Exposure to  
Carcinogens or Mutagens at Work  
(Amendment) Regulations, 2019**

IN EXERCISE of the powers conferred by article 12 of the Occupational Health and Safety Authority Act, the Minister for European Affairs and Equality, after consultation with the Occupational Health and Safety Authority, has made the following regulations:-

**1.** The title of these regulations is the Protection of Workers from the Risks related to Exposure to Carcinogens or Mutagens at Work (Amendment) Regulations, 2019, and these regulations shall be read and construed as one with the Protection of Workers from the Risks related to Exposure to Carcinogens or Mutagens at Work Regulations, hereinafter referred to as "the principal regulations".

**2.** Sub-regulation (6) of regulation 1 of the principal regulation shall be substituted by the following:

"(6) The scope of these regulations is to implement:

(a) Directive 2014/27/EU of the European Parliament and of the Council amending Council Directive 2004/37/EC on the protection of workers from risks related to exposure to carcinogens or mutagens at work; and

(b) Directive 2017/2398 of the European Parliament and of the Council of 12 December 2017 amending Council Directive 2004/37/EC on the protection of workers from the risks related to exposure to carcinogens or mutagens at work."

**3.** Sub-regulation (1) of regulation 14 of the principal regulations shall be substituted by the following:

"(1) The employer shall make arrangements for carrying out relevant health surveillance of workers for whom the results of the assessment referred to in regulation 3 reveal a risk to health or safety. The doctor or Authority may indicate that health

surveillance must continue after the end of exposure for as long as they consider it to be necessary to safeguard the health of the worker concerned."

4. In Schedule I of the principal regulations, immediately after item 5 thereof, there shall be added the following new item: Amends

"(6) Work involving exposure to respirable crystalline silica dust generated by work process".

5. Schedule III of the principal regulations shall be substituted by the following: Substitutes
