Regolamenti ta' l-2010 li jemendaw ir-Regolamenti dwar il-Limitazzjoni ta' Emissjonijiet ta' Komposti Organiċi Volatili (Żebgħa, Verniċi u Prodotti ta' Rifinitura tal-Vetturi)

BIS-SAHHHA tas-setgħat mogħtija bl-artikoli 9 u 10(2) ta' l-Att dwar il-Harsien ta' l-Ambjent, u bl-artikolu 38 ta' l-Att dwar is-Sigurezza tal-Prodotti, il-Prim Ministru għamel dawn ir-regolamenti li ġejjin:-

1. It-titlu ta' dawn ir-regolamenti hu Regolamenti ta' l-2010 li jemendaw ir-Regolamenti dwar il-Limitazzjoni ta' Emissjonijiet ta' Komposti Organiċi Volatili (Żebgħa, Verniċi u Prodotti ta' Rifinitura tal-Vetturi), u għandhom jinqraw u jiftieħmu haġa waħda mar-Regolamenti ta' l-2006 dwar il-Limitazzjoni ta' Emissjonijiet ta' Komposti Organiċi Volatili (Żebgħa, Verniċi u Prodotti ta' Rifinitura tal-Vetturi), hawnhekk iżjed 'il quddiem imsejhin “ir-regolamenti prinċipali”.

Titlu.

A.L. 78 ta' l-2006.

2. Ir-regolament 2 tar-regolamenti prinċipali għandu jiġi emendat kif ġej:

*Jemenda r-regolament
2 tar-regolamenti
prinċipali.*

(a) It-tifsira “kisi” għandha tīgi sostitwita kif ġej:

“ “kisi” tfisser kull taħlita, inkluż kull solvent organiku jew taħlitiet li jkun fihom solventi organici li jkunu meħtieġa għall-applikazzjoni korretta tagħhom li jintuża biex jipprovd iegħi li għandha effett dekorattiv, protettiv jew funzjonal i-eħor fuq il-wiċċ ta' oggett;”;

(b) It-tifsira “preparati” għandha titħassar; u

(c) minnufih wara t-tifsira “sustanzi” għandha tidħol din it-tifsira li ġejja:

“ “taħlita” tfisser taħlitiet jew soluzzjonijet magħmulin minn żewġ sustanzi jew aktar;”.

**Limitation of Emissions of Volatile Organic Compounds
(Paints, Varnishes and Vehicle Refinishing Products)
(Amendment) Regulations, 2010**

BY VIRTUE of the powers conferred by articles 9 and 10(2) of the Environment Protection Act, and by article 38 of the Product Safety Act, the Prime Minister has made the following regulations:-

1. The title of these regulations is the Limitation of Emissions of Volatile Organic Compounds (Paints, Varnishes and Vehicle Refinishing Products) (Amendment) Regulations, 2010, and they shall be read and construed as one with the Limitation of Emissions of Volatile Organic Compounds (Paints, Varnishes and Vehicle Refinishing Products) Regulations, 2006 hereinafter referred to as “the principal regulations”. Citation.
L.N. 78 of 2006.

2. Regulation 2 of the principal regulations shall be amended as follows: Amends regulation
2 of the principal
regulations.

(a) for the definition “coating” there shall be substituted the following:

“ “coating” means any mixture, including all the organic solvents or preparations containing organic solvents necessary for its proper application, which is used to provide a film with decorative, protective or other functional effect on a surface;”;

(b) immediately after the definition “film” there shall be inserted the following new definition:

“ “mixture” means mixtures or solutions composed of two or more substances;”; and

(c) the definition “preparation” shall be deleted.
