MISUSE OF DRUGS ACT 1973  
(AMENDMENT OF THIRD SCHEDULE)  
ORDER 2024

In exercise of the powers conferred by section 59 of the Misuse of Drugs Act 1973, the Minister for Home Affairs makes the following Order:

**Citation and commencement**

1. This Order is the Misuse of Drugs Act 1973 (Amendment of Third Schedule) Order 2024 and comes into operation on 1 December 2024.

**Amendment of Third Schedule**

2. In the Misuse of Drugs Act 1973, in the Third Schedule, in Part 1, in paragraph 1 —

- (a) replace the item “Butan-2-yl 3-(1,3-benzodioxol-5-yl)-2-methyl-2-oxiranecarboxylate also known as 3,4-MDP-2-P methyl glycidic acid, sec-butyl ester” with —

“Butan-2-yl 2-methyl-3-phenyl-2-oxiranecarboxylate also known as P-2-P methyl glycidic acid, sec-butyl ester or sec-butyl 2-methyl-3-phenyl-2-oxiranecarboxylate

Butan-2-yl 3-(1,3-benzodioxol-5-yl)-2-methyl-2-oxiranecarboxylate also known as 3,4-MDP-2-P methyl glycidic acid, sec-butyl ester or sec-butyl 3-(1,3-benzodioxol-5-yl)-2-methyl-2-oxiranecarboxylate

Butyl 2-methyl-3-phenyl-2-oxiranecarboxylate also known as P-2-P methyl glycidic acid, butyl ester”;

- (b) after the item “Ergotamine also known as 12’-Hydroxy-2’-methyl-5’ $\alpha$ -(phenymethyl) ergotaman-3’,6’,18’-trinone”, insert —

“Ethyl 2-methyl-3-phenyl-2-oxiranecarboxylate also known as P-2-P methyl glycidic acid, ethyl ester”;

- (c) after the item “Ethyl 3-(1,3-benzodioxol-5-yl)-2-methyl-2-oxiranecarboxylate also known as 3,4-MDP-2-P methyl glycidic acid, ethyl ester”, insert —

“Isopropyl 2-methyl-3-phenyl-2-oxiranecarboxylate also known as P-2-P methyl glycidic acid, isopropyl ester”;

- (d) after the item “Methyl alpha-phenylacetoacetate (also known as MAPA)”, insert —

“Methyl 2-methyl-3-phenyl-2-oxiranecarboxylate also known as P-2-P methyl glycidic acid, methyl ester”;

- (e) replace the item “2-Methylpropyl 3-(1,3-benzodioxol-5-yl)-2-methyl-2-oxiranecarboxylate also known as 3,4-MDP-2-P methyl glycidic acid, isobutyl ester” with —

“2-Methyl-3-phenyl-2-oxiranecarboxylic acid also known as P-2-P methyl glycidic acid or BMK glycidic acid

2-Methylpropyl 2-methyl-3-phenyl-2-oxiranecarboxylate also known as P-2-P methyl glycidic acid, isobutyl ester or isobutyl 2-methyl-3-phenyl-2-oxiranecarboxylate

2-Methylpropyl 3-(1,3-benzodioxol-5-yl)-2-methyl-2-oxiranecarboxylate also known as 3,4-MDP-2-P methyl glycidic acid, isobutyl ester or isobutyl 3-(1,3-benzodioxol-5-yl)-2-methyl-2-oxiranecarboxylate”;

- (f) after the item “Phenylacetic acid also known as Benzeneacetic acid or  $\alpha$ -Toluic acid”, insert —

“Piperidin-4-one also known as 4-Piperidone”;

- (g) after the item “Potassium permanganate”, insert —

“Propyl 2-methyl-3-phenyl-2-oxiranecarboxylate also known as P-2-P methyl glycidic acid, propyl ester”;

- (h) after the item “Safrole also known as 4-Allyl-1,2-methylenedioxybenzene”, insert —

“tert-Butyl 2-methyl-3-phenyl-2-oxiranecarboxylate also known as P-2-P methyl glycidic acid, tert-butyl ester”; and

- (i) after the item “tert-Butyl 3-(1,3-benzodioxol-5-yl)-2-methyl-2-oxiranecarboxylate also known as 3,4-MDP-2-P methyl glycidic acid, tert-butyl ester”, insert —

“tert-Butyl 4-oxo-1-piperidinecarboxylate also known as 1-Boc-4-piperidone”.
